Monkeypox Declared a Public Health Emergency in Illinois

Illinois Gov. J.B. Pritzker on Monday declared monkeypox a public health emergency, classifying the state as a "disaster area" in regards to the disease.

As of August 2nd, 520 monkeypox virus (MPV) cases have been reported in the state of Illinois. Governor Pritzker has **declared MPV a public health emergency**, and with such declaration allows Illinois to more easily secure MPV vaccines. While current vaccine supplies are low, Chicago Department of Public Health expects to increase supply to ensure all who want the vaccine can access it.

Some **symptoms to watch out for include:** swollen lymph nodes, fever, aches, and rashes on the face and body. Reminder that anyone is at risk, MPV does not target nor discriminate.

MPV transmission occurs primarily from close physical contact with MPV sores, items that have been contaminated with fluids or sores, or through respiratory droplets. At the moment, vaccine eligibility is limited to those with (1) close physical contact with someone diagnosed with MPV in the last 14 days or (2) a sexual partner diagnosed with MPV in the last 14 days. With assistance from Illinois Emergency Management Agency (IEMA), Illinois Department of Public Health can expand vaccine and testing capacities.

Navigator Q&A: Official Marketplace Open Enrollment Period (OEP)

While the Official Marketplace Open Enrollment Period (OEP) is still scheduled to begin on November 1st, many Illinoisians are still eligible to receive a subsidized health insurance plan by qualifying for the Marketplace's Special Enrollment Period (SEP). Beyond specific life events, such as losing employer-based coverage or adding a new family member, residents may also qualify based on the income guidelines determined by the SEP. These guidelines can be found in the chart on the right:
